Users can now search both MIDIRS resources at the same time and find precise information quickly so they can succeed — in class or on the job.



MIDIRS Midwifery Digest on Ovid is an essential publication consisting of news, reviews, original articles and reprints of the best midwifery information from selected journals, websites, books, pamphlets, government reports, conference proceedings and other sources.

Maternity and Infant Care Database

Both in training and in practice, healthcare professionals supporting women during pregnancy, childbirth and the postnatal period are already using the Maternity and Infant Care database on Ovid. Physicians, clinicians, researchers and students can search this bibliographic database of more than 270,000 references drawn from over 400 English language journals, book chapters, reports, guidelines, press releases, conference proceedings and other 'grey' literature.

Produced by MIDIRS, the database was first developed in 1988 and spans a wide range of subject areas — including pregnancy, labor, birth, neonatal and postnatal care, infant feeding, and the midwifery profession. The database also includes details of correspondence and commentary written in response to an article. Many of the records are assigned to one or more of 570 standard searches on key topics in order to provide fast retrieval, using either a code or a browsable index of topics.
